# PUEBLO MUNICIPAL SHOOTERS, INC. ANNUAL RELEASE and WAIVER

I, the undersigned (hereinafter the Participant), by my signature below, intending to be legally bound hereby have reviewed this release and waiver and understand the legal implications of the document.

In consideration of the use of the Pueblo Municipal Shooters, Inc. (hereinafter the Range) facilities including the shooting range and other goods and sufficient consideration, the sufficiency of which is hereby acknowledged, the Participant does for himself, family members, spouse, his heirs, personal representatives and assigns hereby releases, waives and discharges Pueblo Municipal Shooters, Inc., its officers, agents, directors, employees and members from any and all claims, losses, damages of any and all types whatsoever for injury or loss resulting from or on account of the Participant's presence on the property of the Range, and the adjacent grounds or use of the property including but not limited to the shooting range. This release covers the Participant's person or property and includes injuries of any and all type including the death of the Participant whether caused by any act or omission whether negligent or otherwise of the Participant or of any other person while the Participant is present on the Range property, firing range and the property adjacent thereto. This release applies to the signed Participant, spouse and family members. The signed Participant agrees to inform those persons of the risks and assumes all responsibility for the conduct and risk for those persons.

Participant agrees to indemnify and hold harmless Pueblo Municipal Shooters, Inc., its officers, agents, directors, employees and members from any and all fault, loss, liability, damages, costs, claims or lawsuits which may incur or result from the Participant's presence on or use of the range, buildings, land and premises whether caused by negligence or otherwise.

Participant acknowledges that firearms, including those firearms that may be loaded, are present on the property of the Range, and also in and about the buildings and land. The Participant acknowledges that the use of firearms and use of the Range may involve the Participant in inherently dangerous activity which poses the risk of serious bodily injury or death resulting from the acts of the Participant or the acts of others. The Participant hereby expressly assumes the risk associated with presence on the premises and use of the Range.

The Participant expressly agrees this release, waiver and indemnification agreement is intended to be as broad and inclusive as permitted by the laws of the State of Colorado and if any portion thereof is held invalid, it is agreed the balance shall, notwithstanding any other invalidity, continue in full legal force and effect. No remedy conferred by any of the specific provisions of this instrument is intended to be exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition to every other remedy now or hereafter existing at law or in equity or by statute or otherwise.

The Participant understands video cameras are in use inside and outside the Range facility. The Participant agrees to allow their photo, video or film likeness to be used for any legitimate purpose by the Range.

The Participant acknowledges and understands the Range is not duty-bound to render medical aid however, the Participant consents to receive first-aid/medical treatment, which may be deemed advisable in the event of injury, accident and/or illness during the activities at the Range.

The Participant acknowledges and understands this document may be scanned and stored electronically or digitally indefinitely and agrees that such a digitally stored document shall be as authentic and admissible in any litigation or other proceeding as if it were the original signed document.

The Participant has read this instrument and acknowledges, agrees, and understands the legal implications of this instrument and will at all times abide by all rules, policies and procedures of the Range. The Participant acknowledges he is familiar with the rules governing conduct while on the premises and has had an opportunity to inquire of such rules.

The Participant acknowledges any disqualifiers under Federal Form 4473 for owning or handling a firearm also prohibits membership to or use of the Range. The Participant further certifies any family member or their guest(s) using the range can legally shoot and own a firearm.

- Door code verification
- Guest and member sign-in books, applicable fees
- Signage; range rules and the types of firearms and ammunition allowed on the range
- Video surveillance system and explain its purpose
- First aid kits, telephone, emergency and board members telephone numbers
- Recognition/Incident report form and explain its purpose
- NO uncased or un-holstered firearms and permitted behind the firing line
- Booth light timers, switches and target control buttons
- Fresh air intake and heater timer switch (if manual operation is required)

- Responsibility for cleaning area after shooting; brass tubs, trash barrel, dud box location and use
- Emergency exits; main entrance, down range on Lane #4 and by the office
- NO ONE DOWN RANGE: NO ONE, except Board approved, certified NRA instructors conducting classes, are permitted down range, for any reason
- Exit doors with sticky mats
- Hygiene, liquids allowed in prep area, hand washing, etc.
- Restrooms, refrigerator, classroom, classroom lights, classroom curtains, when closed, indicates a class is in session
- Emergency equipment and fire extinguisher locations

## RANGE RULES

- Members sign the BLUE log; Guests sign YELLOW log
- Fees are dropped into RED collection box
- ALWAYS keep muzzle pointed DOWN RANGE
- ALWAYS keep finger off the trigger until ready to shoot
- ALWAYS keep firearms unloaded until ready to use
- Eye and ear protection is required for all persons in the range area when shooting is in progress
- ALL shooting must be done from the shooting booth
- NO cross-lane shooting
- DO NOT shoot the walls, ceiling or floor
- ALL firearms entering and leaving the range must be cased or holstered
- NO uncased or unholstered (naked) firearms outside the shooting booth
- NO ONE DOWN RANGE; do not cross the RED firing line
- Firearms shall only be loaded and unloaded on the firing line; loading magazines is permitted at the back bench
- ONLY paper targets are permitted
- NO ONE under age 18 is allowed to shoot without direct adult supervision
- RSO may ask for age verification
- NO cleaning of firearms in the range
- Shooters shall not consume mind-altering drugs (alcoholic, prescription, marijuana, etc) before or during shooting
- NO smoking of tobacco/marijuana products and electronic cigarettes inside the range facility nor within 25 feet of any entrance

- NO food or open liquid containers are permitted in the shooting area, except bottled water with a screw top lid
- CLEAR all brass, paper and other debris from shooting area
- You may keep your own brass; all other brass must be deposited into the RED buckets for our youth program
- Sign out and make sure the door is locked when leaving the range

### PERMITTED Firearms:

- Air rifles with lead pellets only
- Rimfire rifles and pistols (.17 and .22)
- Center fire pistols with a maximum power factor of .44 magnum
- Black powder with a reduced charge

### PROHIBITED Firearms:

- NO Center fire rifle cartridges
- NO Shotshells
- NO BBs
- NO Steel or armor piercing bullets
- NO Tracers
- NO Fully automatic firearms
- NO Center fire pistols using center fire rifle cartridges
- NO Rifles using center fire pistol cartridges

All of the above orientation items and Range Rules have been explained to me. I fully understand and agree to comply with the Range Rules and the Range's Standard Operating Procedures. I understand failure to comply with the Range Rules by myself, family members, or any of my guests may result in referral to the Free Gun Safety Class or possible membership suspension and/or termination.
