- I. **Call to Order** - The meeting was called to order by President Rick Taullie at 7:12p.m. **Board members present** – Terry Curtis, Bob Covington, Leonard Jimenez, Paula Mitchell, Rick Taullie, Peggy Walker, Ron Wiley, Les Keator, and Chuck Wingfield

IV. **Old Business**

**Building Committee** – The cracked seam on the south side of the building was repaired by member Mike Musso at no charge to the range. Ten 5-gallon buckets were requested by Ron Wiley. **By-laws** – The previously proposed changes were reviewed with the board for presentation to the membership at the annual banquet.

**Incident Review Committee** – Ron Ragazzi has resigned from the committee. There was one incident reported and it was handled satisfactorily with a phone conversation.

**Membership** – There were 11 new members for December bringing the total to 656 members. There were 148 new members for 2015.

**Public Information** – Terry Curtis has updated the Facebook account and continues to do an excellent job with our website.

**SOPs** – An updated Range Cleaning Procedure was submitted. Upon review there was a M/S by B. Covington/T. Curtis to adopt the updated Range Cleaning Procedures. Motion carried.

**Free Gun Safety** – There were 16 in the November class bringing the total to 176 attendees for the year. A session for 2 was held in December to assist individuals who were not able to make a Monday evening slot.

**RSOs** – The RSO schedule is complete through January.

**Pistoleras** – There are 11 members and all are doing well in the classroom and on the range.

**League** – There will be three levels of shooting going forward. Cost will be \$10 registration and \$5/category.

**Jr. Marksman** – This will be the last week. There will be a party and awards will be handed out on December 29<sup>th</sup> at 5:00p.m.
