- II. **Minutes** - It was M/S by B. Covington/L. Keator to approve the minutes of the December 14, 2015 meeting. Motion carried.
- III. **Financial Statements** – Peggy Walker presented the financial reports. It was M/S by C. Wingfield /Les Keator to approve the financial reports. Motion carried.
