- I. **Call to Order** - The meeting was called to order by President Terry Curtis at 6:59 p.m. Board members present – Bob Covington, Terry Curtis, Peggy Walker, Chuck Wingfield, Leonard Jimenez, Rick Quinn, Nick Mangini and Bill Morris. Board members absent – Tom Bailey.
 - II. **Special Presentation** – Freddie Gallegos Jr. from Toys for Tots presented the club with awards and recognition for the Club's effort during the 2016 Toy and cash drive.
 - III. **Minutes** – February 13th, 2017 board meeting minutes were presented by Rick Quinn. A motion to accept the minutes as presented with a spelling correction made by Bill M., 2nd by Bob C. Motion carried.
 - IV. **Financial Report** – February 2017 financial report was presented by Peggy Walker highlighting the PNL statement. Motion to accept the financial statement was made by Bill M., 2nd by Chuck W. Motion carried.

VII. **Range Programs:**

- a. Free Gun Safety – There have been 45 attendees for 2017. There have been 4 classes thus far in 2017. March & April classes are full.
- b. RSOs – Meeting held on February 25th. There are 24 active RSOs. The first aid/CPR requirement necessity was discussed. A motion to no longer require the certification of CPR/first aid was made by Leonard J., 2nd by Peggy W. Motion carried. The RSO SOP to be returned to the SOP committee for that amendment.
- c. Instructors – Meeting held February 25th. Yearly agreements were signed.
- d. Pistoleras – Last meeting for the session was March 13th. Ron R. is stepping down as the program lead. No new session dates have been set. It was discussed to promote further training by the education committee utilizing a program to further the knowledge and shooting skills for all range members. Tabled for now with the education committee to begin considering a program.
- e. Pistol League – 42 shooters signed up with 6 doing the ‘off the chart program’ and there are 4 teams. Two weeks into the program. Megaphone has been purchased and is available for use.
- f. Jr. Marksman – 28 shooters total. Volunteers are needed for Thursday session and Nick M. has been working on that.

- a. Free shoot day scheduled for April 15th, 10 a.m. to 2 p.m. To be organized by Rick Quinn.
- b. Fun shoot day to be organized by the pistol league with the date to be determined.
