- I. **Call to Order:** The meeting was called to order by President Terry Curtis at 7:05 PM. Board members present: Terry Curtis, Bob Covington, Peggy Walker, Nick Mangini, Tom Bailey, Vic Gustafson and Bill Morris. Absent: Christian Nordstrom. It was announced that Rick Quinn resigned from the board and all other duties related to the club as he has moved from the area.
- II. **Minutes:** March 12, 2018 board meeting minutes were read. A motion to accept the minutes made by Peggy W., 2nd by Nick M. Motion carried.
- III. **Financial Report:** March 2018 financial report was presented by Peggy W. Highlighted sections included expenses for filing taxes, tree trimming/removal cost and range supplies for filters and booties. A motion to accept the financial report as presented was made by Vic G., 2nd by Bill M. Motion carried.
- IV. **Old Business:**
 - a. Ceiling fans will be selected by Peggy and arranged for installation.
 - b. "Harming Others" seminar scheduled for May 5th from 1 to 3 PM.
- V. **Committees:**
 - a. Building and Safety presented by Nick M. Motion activated light switch installed in lobby/classroom on 3/21; trees trimmed/removed and general cleanup of the outside area on 3/22; new targets received 3/23; filters changed and replaced fire extinguishers on 3/27; old filters and rubber mats to be picked up 4/9; expect to strip and paint shooting area floor on 4/19 and request the range to be closed from Thursday night at 9 PM to Saturday morning at 8 AM; new black rubber mats have been ordered.
 - b. By-Laws: Nothing to report.
 - c. SOPs: The Incident Review Committee SOP was reviewed and a motion to accept the new SOP was made by Bob C., 2nd by Tom B. Motion carried.
 - d. Incident Review: The previous 6 incidents were resolved by sending letters to the POIs. One new incident reported; the same POI as a previous IRC report.
 - e. Membership: 654 current memberships. April new members: 10; Total for year: 54
Discussion about possible use of credit card for payment on new member night and possibly renewals; Terry C. will report back with options/costs.
 - f. Public Information: Nothing to report.
- VI. **Range Programs:**
 - a. Free Gun Safety: March attendees: 20; Total for year: 64
 - b. RSOs: Tom Bailey is the new Chief RSO. Tom B. renewed the request for an online calendar for RSOs to sign up.
 - c. Instructors: 12 active instructors. Nick M. will be the new Instructor coordinator. Discussion was held about having range-approved instructors participate in some way in the Free Gun Safety Class.

- e. Pistol League: Spring league done. There were 25 participants in the flashlight shoot. Christian N. may act as the board's representative for the next league session.
- f. Jr. Marksman: Current session is almost complete.
